I am hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that, Sh. Aghroy Machhori SO Sh. Lt. Raja Machhori of village Santmali P.O. Sourangdi Dist. Purulia has committed theft of electricity (U/S 120(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 17.08.2012 at about 09:30 PM I SA Suman Kumar Dal. AS & Station Manager, Bagramundh C.C. along with I. Sh. Karulal Ray I.T. & I. Sh. Yashwanth Paramanik & Sh. Anurag Ch. Deb & Sh. T. N. entered the premises of Sh. Aghroy Machhori SO Sh. Lt. Raja Machhori of village Santmali P.O. Sourangdi Dist. Purulia and found Sh. Aghroy Machhori was playing electricity unauthorizedly drawing power from the nearest S & M line of 110/220V through PVC wire by means direct hooking to his house premises and connected load found 0.1 KW. As Sh. Aghroy Machhori SO Sh. Lt. Raja Machhori committed theft of electric power, so, I seized the following articles after preparing the seizure in presence of I. Sh. Karulal Ray I.T. & I. Sh. Yashwanth Paramanik. The inspection team left the premises at 10:15 PM on 17.08.12.
