The complainant above named begs to state as follows:-

1. That the complainant and the accused persons are all residents of village Jardi under P.O. Sargan District Pundia and within the jurisdiction of this C.D. Court.

2. That on 21.1.2017 at about 8 P.M. while the complainant was going to call a mid-wife and while he reached near Jardi P.S. school at that time all the accused persons named above being armed with deadly weapons like, Lathi, Ironrod etc, came and appeared in front of the complainant and they restrained the way of the complainant by waving deadly weapons for the purpose of commit murder of the complainant. There after accused no. 1 Indar Paramanik suddenly assaulted the complainant by iron rod on his head for the purpose of commit murder of the complainant and as a result of which the complainant sustained grievous head injury on the left side of his head and here blood oozed from the head of the complainant. Thereafter the accused Indar Paramanik and Joyra Paramanik also assaulted the complainant by Lathi on his leg. The complainant raised alarm by some people, people hearing the noise the witness no. 1 and 2 came to the spot and they saved the complainant from the bad hands of the accused persons. The complainant identified the accused persons with the help of torch light. The

The witnesses named above saw the incident and the matter was also reported to them.

3. That thereafter the complainant went to police post and Tehsil P.R.G. for his treatment with the help of the witnesses and he reported the matter to the police sub post and thereafter he reported the matter to the C/O Begundi p.s. but police did not take appropriate steps against the accused persons till today. The complainant also reported the matter to the S.P. police on 10.1.2017 but there is no fruitful result. So the complainant has been compelled to take shelter before the L.D. Court.

It is, therefore, prayed that your Honour may be pleased to send this petition of complaint to the C/O Begundi p.s. by treating the same as F.I.R. and to investigate the case as provided under section 154(b) Cr.P.C.
