I do hereby lodge complaint empowered by enacting the electricity act 2006 subsequently the amendment act 2007 to the effect that, In Sachivalay Kandarpur Block in Bardhaman District of village Gokulnagar, P.D. Malda, Mrs. Purna has committed theft of electricity via illegal tap of electricity act 2006 subsequently amendment act 2007.

On 25-11-17, at about 6 : 30 P.M., Mr. Bhawan Kumar Das, M.I. & Venues Manager, Bapujiwada CGC along with I. Akash H. Patel L.M. I.C. & Inspector C.R. - Ramakant H. R. T.S. I. - entered the premises of Sri Bapujiwada K.C. at village Bapujiwada, P.O. Bapujiwada. It was found that there were no defects in the wiring system and found Sri. Bapujiwada K.C. was importing electricity unauthorizedly drawing power from the nearest L. B.M.V line of W.B.E.D.C. through PVC wire by means direct leading to his house premises and connected load from C.I.E. box. As Sri. Bapujiwada K.C. I.C. - Sri. Bapujiwada K.C. committed theft of electric power. So, I seized the following articles after preparing the search warrant in presence of I. Sri. Akash H. Patel L.M. I.C. & Bapujiwada K.C. B.M.P. The inspection team left the premises at 8 : 15 P.M. on 26-11-17.
