I SI Subrata Sadhu of Balarampur PS do hereby lodge a complaint. as suomoto against approx 90 unknown female & male villagers of different villages of Baraurma GP & other GP area under Balarampur PS Dist-Purulia. that today (06.05.2017) at about 10.25 hrs when I am performing mobile duty through NH-32 Purulia Tata main road under Balarampur PS area & getting information regarding sudden gathering of people at Namsole Tamli Para more, myself along with ASI Dinabandhu Bouri C/942 Dipak Mukherjee, C/110 Uday Bhanu Ballav, C/1042 Prakash Mondal & C/386 Shibendu Sinha went to Namsole Tamli Para more and found that approx 90 unknown villagers of different villages of Baraurma GP & other Gp area under Balarampur PS Dist- Purulia had obstructed Purulia - Tata (NH 32) road at Namsole Tamli Para more under Balarampur PS and vehicular traffic was getting disrupted. Ongoing buses, trucks and other vehicles were stopped remitting all people got stuck. They raised slogans against the Govt. for antipeople policy. A tumultuous situation occurred and after several request to the agitators but did not pay any beed to withdraw the blockade. Finding no alternative I declared the mob as unlawful assembly and asked them to disperse, though they did not pay any attention. As we were scanty in number, so I prayed for reinforcement. Again I prolonged discussion with them they withdrew the blockade at 11.05 hrs and decamped calmly. Vehicular traffic became normal.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S-143/341/283/506 IPC & 18 W.B. Highway Act 1964 approx 90 unknown female & male villagers of different villages of Baraurma GP & other GP area under Balarampur PS Dist-Purulia and arrange for its investigation.
