Dear Sir,

I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Azul Army, 3/6 Sarif Army residing at Balarampur, Masjid Road, P.S. Balarampur is enjoying electricity illegally by way of direct hooking from the nearby L.T.O.H line of W.B.S.E.D.C.L. He has committed theft of electricity U/S 135 of The Electricity (Amendment) Act-2007.

Entered the premises of Azul Army, 3/6 Sarif Army at via: Masjid Road Balarampur, P.S. Balarampur, Dist. Purulia. It was found that Azul Army is residing at the house of Sarif Army & using electrical equipments illegally and inspected without permission. During inspection theft of electricity was detected i.e. he was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (I) (a) was detected.
