At the time of inspection the unauthorized user was enjoying electricity from two lamps of 300 watt each and thus Connected load stands at 0.34 KVA out of which the undersigned selzed one lamp along with approx. 10 meters flexible PVC wire in length with booking device. We left the premises at 1.50 p.m.

The said person has committed an offence U/S 135(1)/a of electricity act 2005 subsequently electricity (Amendment) act-2007.
