I do hereby lodge complaint, empowered by enacting "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri Paban Murmu S/O Shri Malinda Murmu was enjoying electricity unauthorizedly by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135 (1a) of the electricity (Amendment act-2007).

On 08.05.2017 at 2 p.m. I, Sri Subal Ch. Dey, D.E & S.M., BARABAZAR CCC along with

- (1) Chandl Charan Karmakar, A.C.M., S/O Late Gurupada Karmakar
- (2) Amarananda Mahato, Gr. I T.S.H., S/O Late Jitendra Nath Mahato

Entered into the premises of Shri Paban Murmu S/O Shri Malinda Murmu and inspected his premises at Vill- Dubrajpur, Dist- Purulia, P.S- Barabazar.

During inspection, it was found that Shri Paban Murmu S/O Shri Malinda Murmu was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at Dubrajpur with the help of double bare flexible PVC copper conductor of approximately 10 mm. At the time of inspection the unauthorized user was enjoying electricity from two lamps of 100 watt each and thus Connected load stands at 0.24 KVA out of which the undersigned seized one lamp along with approx. 30 meters flexible PVC wire in length with hooking device. We left the premises at 2.20 p.m.

The said person has committed an offence U/S 135(1a) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per law.
