In producing herewith the accused persons 1. Sect. Manju Mahato (33) W/O Harirom Mahato of Parsha 2, Smt. Amala Paramanik (50) W/O Bibhuti Paramanik of Do 3, Parbati Mahato (30) W/O Subodh Mahato of Do 4, Kajali Mahato (45) D/O Bhadru Mahato of Do 5. Bhagyabati Mahato (37) W/O Jaglasdish Mahoto of Do 6. Sest Dumini Mahato (36) W/O Gobinda Mahato of Ithabanipur alli under Baraburur PS, District Purulia under arrest and proper arrest memo, I SI Kabi Ranjan Singha (aged 50 year) S/O- Late Sanatan Singha, now attached to Barabazar PS do hereby lodge a written complaint against the above noted accused persons and unknown 300 others (approx.) women and a group of men to the effect that on 08.05.2017 at 15.15 hours I received information from ASI Muktinath Chakraborty duty officer of the PS that he was requested by Shri Souvik Bhattacharjee, WBCS (Exc.) BDO Barabazar that around 300 (approx.) unknown women of Self Helf Group had assembled at Tumrasole Gram Panchayet office under this PS area over the issue of envolment of their name in NREGA scheme. Initially a hot altercation happened between women of self help group and member of GPs. Soon they started assaulting the Pradhan and Upa Pradhan of Tumrasole GP and damaged some furniture of the said G.P office. Subsequently the information was passed to the BDO Barabazar and through Duty Officer and he requested to look into the matter and the matter was diarised vide GDE No. 405 dated 08.05.2017. As I was already on duty vide MCC No. 1565 dated 08.05.2017 the said information was imparted to me. Accordingly, myself along with SI Hemanta Kurnar Sahababu, ASI Shymal Chandra Mandal, ASI Sarif Ali Khan, ASI Gnan Sankar Pati, ASI (AB) Kartick Chandra Pal & 09 Constable and 02 Ludy Constable proceeded to the spot, i.e. Turnrasole GP office to work out of the information. On arrival at the Turnrasole GP Office I found that the main entrance of the Tumrasole G.P. Office was blocked by the unknown 300 women (approx.) who were shouting against the Pradhon and Upa Pradhon of said GP. I requested them to let me know what had happened actually there and also reason of their assembly but they were found more furious and were not listening to my words. I tried to pacify them but all went in vain. Meanwhile reinforcement was made from Purulia Police Line and 10 lady constables arrived to assist me to perform law and order duty there. It was found that the GP office was virtually locked by the agitating women. With the assistance of my Lady Police I again tried to pacify them but they did not pay any heed to my words. Even I was not allowed to enter into the GP Office. In the mean time, a group of men suddenly appeared from side outs and joined the women to strengthen their demand. This group of men were instigating the agitating women to continue the shouting and not to cooperate with police. Under this circumstance I declared the assembly of people unlawful and commanded them to be dispersed but they became more violent and started pelting stones and brickbuts aiming at Police following which one Lady Constable 366 Archana Mahato was injured on her forehead severely. She was bleeding profusely. Some officers and constables also sustained injuries. Having no other alternative way I had to arrest the aforesaid accused persons with strict regard to decency from the spot with the help of lady constables and took initiative to disperse the assembly of the people from there. Lady Constable 366 Archana Mahato was shifted to Barabazar BPHC for her treatment. The doctor referred her to Sadar Hospital, Purulia for better treatment. Accused persons were offered free medical cheek up but they did not require.
