I do hereby lodge complaint, empowered by existing "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Shri ASHIM MURMU S/O SURENDRANATH MURMU OF VILL BARADH (MAKHIPARA), P.S.-BARABAZAR was enjoying electricity unauthoritarily by illegal hooking from nearest LT overhead line and he has committed theft of electricity U/S 135(1)(a) of the electricity (Amendment) act-2007.

On 17.05.2017 I, Sri SUBAL CH. DEY, D.E. & S.M., BARABAZAR CCC along with

- (1) AMIT SING S.A.C. (I) S/o Sanatan Sing, VII Laupara, P.S - Bekharia, Dist- Paschim Medinipur
- (2) CHANDI CHARAN KARMAKAR, ACM, S/O LT GURUPADA KARMAKAR, VES-P-5-KATWA, Dist- BURDWAN

Entered into the premises of ASHIM MURMU S/O SURENDRANATH MURMU OF VILL BARADH (MAKHIPARA) P.S.-BARABAZAR at 11:05 a.m. and inspected his premises at VILL BARADH (MAKHIPARA), P.S.-BARABAZAR, DIST.-PURULIA.

During inspection, it was found that ASHIM MURMU S/O SURENDRANATH MURMU OF VILL BARADH (MAKHIPARA), P.S.-BARABAZAR was enjoying electricity illegally by using direct hooking from the nearest LT overhead line in his premises at BARADH (MAKHIPARA) with the help of having connected load 0.117 KVA.

From the above arrangement he was using the following equipment.

1. 01 No Lamp (100 Watt)
2. 2 Core flexible wire (2 mts approx) with switch board and hooking device.

Out of which I seized the following articles.

1. 01 No Lamp (300 Watt)
2. 2 core flexible wire (9 mts. Approx) with switch board and hooking device

Seizure list was prepared at site and accused person refused to sign, after the process of inspection and preparing the seizure list we left the premises at about 11:35 a.m.

The said person has committed an offence U/S 135(1)(a) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as if J.R and action may be taken as per rule.
