Seizure list was prepared at the site, representative of the accused person, the accused person refused to sign/sign.

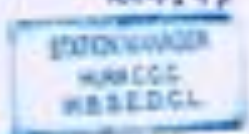
The inspection team left the premises at 04.30 pm on 20-05-2017
