**Sub:** Complaint regarding serious threat faced by the authorities of the YSS Lakhimpur Ashram and Boys' School

Sir,

This is to inform you that on May 13, 2017 around 8:30 am around 30 to 40 people of Lakhimpur village came into the Kripa Sangha Lakhimpur Ashram and gheraoed the Secretary of the Yogoda Ashram and Schools for about 2 hours. They abused the Secretary and used filthy language against the Head Master of the Boys School who was not present at the spot. Their language was extremely filthy, abusive and disgusting. Their demand was that the legal notice served on some village people to vacate the school land no. 3182 is illegal and the Secretary must admit in writing that the notice served was illegal and it has to be withdrawn with immediate effect. They even threatened to physically remove the Secretary from the Yogoda Ashram premises. They have also threatened to remove the Ashram appointed Secretary from the Ashram quarters provided to the Ashram and have threatened to lock up the Boys' School gate and迫使 the Head Master to run the school. It was apprehended from their violent movement and gestures that they perhaps were prepared with an intention to carry out their ultimate violent mission.

Their language and attitude was extremely violent and if they continue their behaviour, they will pose a very serious threat toward running of the School and the Ashram. We had to inform the SOO, Huk, and the DC, Mure II, about the 'gherao'. On receiving a phone call from the DC, the people left shouting in filthy language and threatening to remove the Secretary from the Ashram quarters and the Head Master from the Boys School. After getting out of the Ashram premises, I came to know that these people were waiting outside the Boys School gate in large numbers with an intention to hassle the Head Master.

The situation has taken a very ugly turn and it is not possible to safely run the school and the ashram under these conditions. We are afraid that any kind of dangerous situation might erupt at any point of time. The future of hundreds of students of this institution which was recently awarded as the best school of the district will be jeopardized if such elements are allowed to continue this way.

Some of the persons who had 'gheraoed' and threatened the Secretary and used filthy and abusive language under the leadership of Mr. Bharat Neogi are from Lakhimpur village and were identified as:
