In Producing here with one arrested accd. Person namely Naresh Rajak (45) S/O Janak Rajak of Vill. Hensabatu, P.S. Jhalda, Dist. Purulia brought under arrest with seized article. 01 plastic bag containing 10 (Ten) bottles of Dil Se (Country sprit) each bottle 600 ml. from his possession. 1 do hereby lodged this written complain to the effect that on-30/04/2017 at 16:15 hrs. I received telephonic source information that one person selling (Country sprit) at Hensabatu Village. I inform the matter to I/C Jhalda P.S. over Phone as per his direction myself along with St Tufan Kr. Dawn, ASI- Basudeb Acharya IC/558- Amit Kr. Mishra, IC/559- Amiya Singha Mahapatra vide C.C. No. 1306 / 17 Dtd-30/04/17 left for Hensabatu village to work out the information. We reached at Hensabatu Village at about 18:15 Hours and held raid in the house of Naresh Rajak (45) S/O Janak Rajak of Vill. Hensabatu, P.S. Jhalda, Dist. Purulia and found that the accused person selling Dil Se in his premises accordingly I seized the 91(One) plastic bag containing 10 (Ten) bottles of Dil Se (Country sprit) each bottle 600 ml. under proper seizure list duly signed by the witnesses as well as accused person with proper label. I search for local witnesses but found none.

Accordingly I arrested accd. Naresh Rajak (45) S/O Janak Rajak of Vill. Hensahatu, P.S. Jhalda, Dist. Purulia having maintained all formalities after issuing arrest memo. On integration he confessed that he selling the said Dil Se (Country sprit) to the villagers in lieu of money. On demand he could not produce any valid documents/license in favour of selling the same. So he committed offence punishable U/S = 46 (A) (c) of B.E. Act. 1909.

On return to P.S. along with accd, person and all seized articles. Put the accd, Person in the Lock UP after maintaining all formalities and seized articles kept in P.S. Malkhana and I submitted written complaint before I/C Jhalda P.S. to start a case against Naresh Rajak [45] S/O Janak Rajak of Vill. Hensahatu, P.S. Jhalda, Dist. Purulin under proper section of law.
