Entered the premises of Nitai Barhaik VII Pukurhigram P.S. Jhalda Dist- Purulia, having Consumer No. 20+340725, Meter No. P11732435 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S135(1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his home without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipment.

- 1) Electric Bulb - 02 nos.
- 2) Electric Fan - 03 nos.
- 3) Fridge - 01 no.
- 4) Color TV - 01 no.

Out of which I seized the following

- 1) PVC 2 core cable with bypassing arrangement - 03 ft' (APPROX).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1:00 PM on 03/05/17. The accused person has committed an offence U/S135(1)(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
