I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Bhijuram Mahato was enjoying electricity unauthorizedly by bypassing of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/s 135 of the electricity (Amendment act- 2007) on 08/05/17 at 1:50 PM at Post: Madh. Tulin, AE-Station Manager, Jhaldah C.C.C., WBSEDCL.

Entered the premises of Bhijuram Mahato VIII Madh. Tulin
P.S. Jhaldah Dist- Purulia, having Consumer No. 242089181, Meter No. 92202471
and inspected his premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135 (1)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his home without energy registration in WBSEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments

- 1) Electric Bulb - 02 nos ;
- 2) Electric Fan - 05 nos ;
- 3) CFL - 10 nos.
- 4) Color TV - 02 nos ;
- 5) Freeze - 01 no.

Out of which I seized the following

- 1) PVC two core cable with by passing wire - 60 ft' (Approx).

Seizure list was prepared at the site and accused person refuse to sign/signature. The inspection team left the premises at 2:15 PM on 08/05/17. The accused person has committed an offence U/S 135 (1)(b) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.
