In producing herewith one Satya Mahato (56) S/O Lt. Gurucharan Mahato of Village-Ranidih, P.S- Ibalda, Dist- Purulia and seized (1) 12 (Twelve) sealed bottles PHENCYREX syrup 100 ml. each butch no- 03126SDMB1 mfg. date Dec. 2016 Exp. Date- Nov. 2018, (2) 18 (Eighteen) sealed bottles PHENCYREX syrup 100 ml. each batch no- 03106SMB1 mfg, date Oct. - 2016 Exp. Date- Sept. 2018 I beg to report that today 14,05.17 at 19:15 hrs received a telephonic information from my source that one person is coming from Jargo side towards Ichag side with huge quantities of Drugs. Having received this information, I informed I/C Jhalda P.S. and as per his direction myself along with force who were performing evening mobile duty rushed to Ichag side and keep our vehicle at Ichag High School More. We were waiting at near Deben Mahato welfare society of Ichag. Few minutes later at 20:05 hrs we found one person coming from Jargo side towards Ichag and stopped in front of "Bhabani Medical Hall". We immediately intercepted him at the said spot i.e in front of "Bhabani Medical Hall". On being asked he disclosed his identity as Satya Mahato S/O-Lt. Gurucharan Mahato of Village-Ranidih, PS- Jhalda, Dist- Purulia. On search, we found the accused person was carrying one white colour polythin hand bag loaded with 30 (Thirty) bottles PHENCYREX syrup. On interrogation, he also disclosed that he procured all those from Ranchi side of Jharkhand state clandestinely. On demand he failed to produce any valid documents/ license and medical prescription in respect of keeping the said Drugs. So I seized the same and arrested the accused person having maintained all formalities for violating the sec. 27 of drugs & cosmetics Act- 1940.

On return to P.S I, SI Sahadev Jana submitted a typed written complaint to I/C Jhalda PS to start a case under sec. 27 of Drugs & Cosmetics Act- 1940 against the accused person Satya Mahato S/O Lt-Gurucharan Mahato of village-Ranidih, P.S-Jhalda, Dist.- Purulia and as per direction I handed over seized articles to the Malkhana officer.
