Sir,

In Producing here with one arrested accd. Person namely Shib Ram Mahato Aged 60 Yrs. S/O Lt. Haradhan Mahato of Vill. Magha, P.S. Jhalda, Dist. Purulia brought under arrest with seized article 01(One) white coloured plastic jar cane containing approx 12 (Twelve) Ltrs of I.D. Liquor from his possession. I do hereby lodged this written complain to the effect that Today i.e. 24/05/2017 at about 10.05 hours during my Patrolling Duty I received telephonic source information that one person selling illegal I.D. Liquor at Magha Village in lieu of Money. I inform the matter to I/C Jhalda P.S over Phone as per his direction myself along with 01 (one) left for Magha to work out the information. We reached at Magha Village at about 19.05 hours and keep our vehicle on the Road. We proceeded on foot through the open field towards near house of accused Village Magha as shown by our source. After about 0.5 KM. walking we found one person is sitting with 01(One) white plastic jar cane containing approx 12(Twelve) Ltrs of I.D. Liquor and some person gathered in front of him. On seeing police party they started to flee away after a small chase we are manage to detain one person, on being asked he disclosed his identity as noted above. On search we found 01(One) white plastic jar cane containing approx 12(Twelve) Ltrs of I.D. Liquor on his hand. On interrogation he stated that he use to sale the I.D. Liquor in lieu of Money for his illegal gain. On demand he also failed to produce any valid challan / Papers in respect of I.D. Liquor. Hence he violated the provision of 46 (A) (c) of R.E. Act.

Accordingly I arrested accd. Shib Ram Mahato Aged 60 Yrs. S/O Lt. Haradhan Mahato of Vill. Magha, P.S. Jhalda, Dist. Purulia and prepared arrest memo and seized the 01(One) white plastic jar cane containing approx 12(Twelve) Ltrs of I.D. Liquor from the possession of Shib Ram Mahato Aged 60 Yrs. S/O Lt. Haradhan Mahato of Vill. Magha, P.S. Jhalda, Dist. Purulia after preparing proper seizure list duly signed by the accd. Person and witnesses and prepared proper label for seized articles duly signed by the accd. Person and witnesses. I search for local public witnesses but found none.

I return to P.S. along with accd. person and all seized articles. Put the accd. Person in the Lock UP after maintaining all formalities and submitted this written complain before you to started a case against Shib Ram Mahato Aged 60 Yrs. S/O Lt. Haradhan Mahato of Vill. Magha, P.S. Jhalda, Dist. Purulia under proper section of law.
