We reached at Magha Village at about 19.05 Bours and keep our vehicle on the Road. We proceeded on foot through the open field towards near house of accused Village Magha at shown by our source. After about 0.5 KM, walking we found one person is sitting with 01(One) white plastic jar case containing appear 12(Tweive) Lira of LD. Liquor and some person gathered in front of him. On seeing police party they started to flew away after a small chase we are manage to detain one person, on being asked he disclosed his identity as noted above. On search we found 01(One) white plastic Jar cane containing approx-12(Twelve) Lirs of LD. Liquor on his hand. On Interrogation he stated that he use to sale the LD. Liquor in lieu of Money for his illegal gain. On demand he also failed to produce any valid challan / Papers in respect of I.O. Liquor. Hence he violated the provision of 46 (A) (c) of R.E. Act.

Accordingly I arrested acod. Shib Ram Mahato Aged 60 Yrs. S/O Lt. Harailhan Mahato of Vill. Magha, P.S. [halds, Dist. Purulia and prypared arrest memo and seized the 01(One) white plastic jar cane containing approx. 12(Twelve) Ltrs. of LD. Liquor from the possession of Shib Itam Mahato Aged 60 Yrs. S/O Lt.
