Most respectfully begs to state:-

1) That, the complainant is the permanent resident of Village-Deondara, Post and P.S.-Jhalka, District-Parulla, West Bengal.

That, on 14/01/2017 at about 7.30 P.M when her son Ajit Kanda aged about 35 years was returning to home after his day labour work and when he reached in between Village-Bargram and Deon derar at that time one truck bearing registration No. JH-01AQ/3557 which was taking back in a rash and negligent manner of driving by the driver of the truck bearing registration No. JH-01AQ/3557 dashed her son as a result her son was grievously injured and died on the spot.

- 3) That, the accident took place due to rash and negligent manner of driving by the driver of the truck bearing registration No. JH-01AQ/3557, the post mortem of the dead body of her son was held at Deben Mahato Badar hospital at Parulia vide P.M. No.34 dated-15/01/2017 and Jhalka P.S. U/D Case No.02/2017 dated-15/01/2017 done by Dr. Tapas Sinha in which he stated that death was due to the effects of injuries as noted above - anti mortem in nature.
- 4) That, the Jhalka police station officer Bahadeb Jana handed over the copy to take the dead body of her son and the complainant is submitting all the copies such as dead body challan, post mortem report.
- 5) That, the complainant for the several times visited at Jhalka police station but the officer-in-charge did not lodged her complaint although she handed over the F.I.R in written, the officer-in-charge harassed her and used to told her that there is no officer to lodge her complaint.
- 6) That, the case is of accident and her son died in the said accident and it is well settled that she will get the compensation from the insurance company but as the officer-in-charge did not lodged her complaint so she is unable to file an application for getting compensation.
- 7) That, the complainant informed the matter in written to S.P Parulia on 17/04/2017 and afterwards again she visited at Jhalka police station but no fruitful result came out and the officer-in-charge again denied to lodge any complaint.



It is therefore prayed that Honour may graciously be pleased to admit this misc. petition and pass necessary order/orders to send this misc petition at Jhalka police station after treating this as a F.I.R U/S 156(3) or p.c to investigate this case so that the accused person be punished as per law.
