In producing here with one Dhananjay Bauri (42) S/O - Gopal Bauri of village Kalidaha Kalidaha (Huchuk Para), PS- Kashipur, Dist- Purulia along with following seized articles viz-

- 1) 19 Liters (Approx) of country spirit contained in a plastic container
- 2) 150 grams (Approx) NISHADAL.
- 3) Four pieces of plastic glass &
- 4) Sale proceed of Rs. 120/-

I SI Nani Gopal Si of Kashipur P.S. do here by lodged a complaint against accd. namely Dhananjay Bauri (42) S/O - Gopal Bauri of village Kalidaha (Huchuk Para), PS- Kashipur, Dist- Purulia to the effect that today (28.05.17) at about 18.45 hrs in course of mobile duty I received a telephonic information from a reliable source that accd. Dhananjay Bauri (42) S/O - Gopal Bauri of village Kalidaha (Huchuk para), PS- Kashipur, Dist- Purulia stocked country spirit illegally at his house at Kalidaha (Huchuk para) village and selling the same to hike price for his personal gain. I informed the matter to OIC Kashipur PS and as per order of OIC Kashipur PS myself along with JC/977 Tarun Kadam and NFI/1068 Narahari Mandi both of Kashipur PS rushed to the spot for holding raid by Govt vehicle. At about 19.35 hrs myself along with force reached at Kalidaha (Huchuk Para) village and held raid in the house of Dhananjay Bauri (42) S/O - Gopal Bauri of village Kalidaha (Huchuk Para), PS- Kashipur, Dist- Purulia and found that Dhananjay Bauri was mixing the country spirit, contained in plastic container, with some intoxicated substance (like white powder) having acrid smell which is likely to cause disability or death to human being, at his house at Kalidaha (Huchuk Para) village and seeing the police party liquor customer fled away but police party anyhow managed to apprehend accd Dhananjay Bauri, and detained him. I asked him about the white powder like substance and accordingly, detained Dhananjay Bauri recognized it as "NISHADAL" (approx. 150 gms contained in a plastic) an intoxicated substance having acrid smell which is likely to cause disability or death to human being. So I arrested the above mentioned accused person informing the ground of arrest and seized the above mentioned articles after preparing proper seizure list duly sign by accd person and available witnesses and also sealed and labeled the same.

Hence I therefore pray that a specific case may kindly be started under proper section of law against arrested accd. Dhananjay Bauri (42) S/O - Gopal Bauri of village Kalidaha (Huchuk Para), PS- Kashipur, Dist- Purulia and arrange for its investigation.
