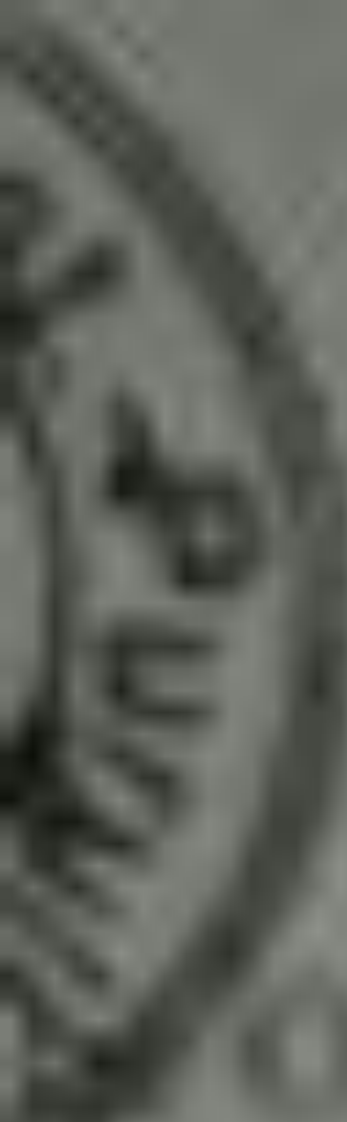

Sir,
In producing herewith one seized vehicle (Tractor) without registration number bearing Engine number -E 3077878 and Chassis no- B 3071565 loaded with stone. The fact of the case in brief is that on 12/05/2017, I along with force were on day mobile duty on Kashipur - Chatna road. During mobile duty on 12/05/17 at about 14:25 hrs received a credible source information that the above noted Tractor is coming from Pabra side towards Kultora village loaded with stone. After receiving this information we were proceeding towards Kultora more under Kashipur P.S. When we reached near Kultora more under Kashipur P.S, found that the above noted (Tractor) was coming from pabra village. On seeing the Police party the driver of the said tractor stopped the tractor in a distance from Kultora village and tried to unload the stone loaded in the said tractor. We rushed to the tractor and the driver then fled away after keeping the tractor near Kultora more at 15:05 hrs. We searched the said tractor and found that the tractor is loaded with stone. I searched for any valid documents in respect of stone loaded in the tractor as well as the valid documents in respect of that tractor but nothing found. Hence I seized the tractor bearing Engine number -E 3077878 and Chassis no- B 3071565 loaded with stone in the trolley under proper seizure list in presence of available witnesses duly signed by them. Thereafter arranging a driver from my source I brought the said tractor to Kashipur P.S. As such there is every reason so believe that the driver and owner of the vehicle with ill motive are transporting the stone illegally without any valid document in support of carrying stone. So they are liable for offence punishable U/S- 379(411)/414/120B IPC & 21 (1)(4) Mines and Minerals (R&D) Act-1957.

Therefore, I pray before you that a case against the driver and owner of vehicle (Tractor) bearing Engine number -E 3077878 and Chassis no- B 3071565 may kindly be started and arrange for its investigation.
