In producing herewith one accd. Bhaju Mahato (52) S/O Lt. Joytilal Mahato, of Murguma, P.S. - Kotshila Dist - Purulia with seizure of 03 (Three) liters illicit spirit containing one Jarican, one used big size handi, 04 Kg. mithua, one used ~~of~~ 05 liters plastic empty Jarican, one polythene pipe length about 01 meter, 1D Liquor containing in a plastic Jarican approx 05 Ltrs, all are used and possession of materials for manufacturing and selling of spirit which was seized under proper seizure list.

I beg to submit that today (28.05.17) in between 17.35 hrs to 18.00 hrs a raid was conducted in the house of Bhaju Mahato, S/O Lt. Joytilal Mahato, of Murguma, P.S. - Kotshila Dist - Purulia. On acting a secret source information against for unlawful manufacture of spirit and selling of intoxicating drug use and possession of materials for manufacture of spirit and intoxicating drug, which were manufacturing in the house of accd. person. On demand he failed to produce any valid documentary authority in respect of selling and manufacturing of illicit spirit which is kept in Jarican approx 05 liters, one used big size handi, one used empty 10 liters Jarican, 04 Kg. (Approx) mithua, one polythene pipe length about 01 meter from the possession of accd person. Which was seized under proper seizure list which enclosed here with. During arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr.P.C. and handed a copy of the same to arrestee.

The above noted arrested accd namely (1) Bhaju Mahato (55. Yrs) S/O Lt. Joytilal Mahato, of Murguma (Tantipara), P.S. - Kotshila Dist - Purulia Committed offence u/s- 18 (i) B.E. Act. For possession of intoxicating not obtained from a licensed vendor and in contravention.
