In producing herewith arrested accused person (1) Krishna Mahato @ Gurikuta (25)S/O Purna Chandra Mahato @ Gurikuta of village- Jitujuri Kamarpara, PS- Manhazar, Dist- PURULIA and apprehended Juvenile conflict with law name Jaydeb Mahato @ Gurikuta (16) S/O LT- Ananda Mahato @ Gurikuta of village- Jitujuri Kamarpara , PS-Manhazar, Dist- Purulia along with seized articles (1) One Challan (2) Rs- 240/-(3) under proper seizure list I beg to report that , today (11.05.17) at around 14:45 hrs in course of my day mobile duty along with C/549 Nagendranath Mahato and C/244 Krishnapada Mukherjee. Received telephonic information that some youths were collecting subscription at Jitujuri forcefully and unlawfully from the drivers of vehicles by intercepting them and none was spared. Accordingly myself along with my accompanying forces left for working out the information after consulting with O/C Manbazar P.S. over mobile phone, we reached at Jitujuri More at around 14:05hrs, and found that a good number of vehicles including some ambulances were intercepted for a long line. We parked our vehicle at a distance and proceeded to the spot on foot and after arriving at the centre we found some youths were extorting money forcefully from the driver of the vehicles threatening them. On seeing police they started running but after a hot chase I apprehended the above noted persons while some 10/12 others managed to flee away. On interrogation they revealed their identity as noted above and also confessed their guilt by saying that they were forcefully collecting money from the driver for themselves illegally and they also issued challan. Accordingly I seized Cash RS- 240/- and a challan book and arrested the above noted one accd person and apprehended one juvenile conflict with law for their interrogation to detect their co accused persons and as the offence committed in presence of me.

Hence I pray that a specific case may kindly be started against them and arrange for its investigation.
