District Purulia armed with lathi, bamboo stick, and brickbats assaulted the on-duty police party with a view to prevent them from taking the above mentioned four arrested accused persons into custody causing thereby disturbance and obstruction in the discharge of official work by the on-duty police men. Consequently chaos developed and one of the arrested accused persons received a blow and fell down causing some injury on left wrist. He was provided medical assistance at the earliest. Four munitions were burst to control the situation. The injured police personnel were also provided medical treatment at Manbazar hospital.

I, therefore, recorded Manbazar PS Case No. 21/17 dated 11.05.2017 U/S 147/148/149/186/353/427/332/333/307/109/114 IPC R/W Sec 18 West Bengal State Highway Act, 9 Maintenance of Public Order Act and 15A(b) West Bengal Maintenance of Public Order (Amendment) Act 2017 and directed SI Uttam Kumar Mondal to investigate the case.
