In producing herewith the accused persons 1. Biswajit Karmakar (42) S/O Late Guiram Karmakar of Jitijuri Karmakarpara 2. Uttam Karmakar (55) S/O Late Haripada Karmakar of Do 3. Sraban Mahato @ Gurikuta (60) S/O Late Jogeswar Mahato @ Gurikuta of Jitijuri Majhpara (Gurikutapara) 4. Dhananjoy Mahato (19) S/O Sraban Mahato @ Gurikuta of Do all under Manbazar PS District Purulia under arrest and proper arrest memo, I SI Debasis Bandyopadhyay (aged 55 year) OC Manbazar PS S/O-Late Satyadas Bandyopadhyay do hereby lodge a written complaint against the above noted accused persons and 1. Pastubala Gurikuta W/O Sraban Gurikuta of Jitijuri Majhpara PS Manbazar District Purulia 2. Smt. Monibala Gurikuta W/O Mathan Gurikuta of Do 3. Sent Sarala Gurikuta W/O Late Kaliram of Do 4. Sent. Malati Gurikuta W/O Panru Gurikuta of Do 5. Smt Jabi Gurikuta W/O Rabidas Gurikuta of do 6. Naru Bairagi S/O Gopal Bairagi of Jitijuri PS Manbazar District Purulia and unknown 600 others (approx.) men and a group of women numbering 100 others (approx.) to the effect that on 11.05.2017 at 16.35 hours I received information from CVF of Jitijuri to the effect that around 600/700 (approx.) unknown person of Jitijuri had blockaded Purulin-Manbuzar Road at Jitijuri proper under this PS area over the issue of arrest of two persons who were arrested for extortion a short while ago in c/w Manbazar PS Case No. 20/17 dated 11,05,2017 U/S 384/34 IPC R/W sec 18 West Bengal State Highway Act. As a result a good number of buses and other vehicles from both sides were compelled to stop forcefully. This information was diarised vide PS GDE No. 417 Dated 11.05.2017. Accordingly, myself along with SI Shiba Prasad Patra, ASI SK Ali Hossain, ASI Rabin Mukherjee and force with two Lady Constables namely JLC/1112 Rebati. Mahato and JLC/1117 Dipti Mahato proceeded to the spot, i.e. Jitijuri proper to work out the information. On arrival at Jitijuri proper I found that Purulia-Manbazar State Highway was blocked by the unknown 600/700 (approx.) people who were shouting against police for allegedly arresting of their men on trivial issue like collection of money in the name of subscription for Puja for which a good number of buses and other vehicles from both sides were forced to be detained there. I requested them to withdraw but they were found more furious and were not listening to my words. I tried to pacify them but all went in vain. They enhanced their demand of not merely releasing the two who were picked up for extortion of money but to escort them from PS to Jitijuri by police van after their release. With the assistance of my officers and force I again tried to pacify them but they did not pay any heed to my words and threw brickbuts airning at the wind screen of a truck even in presence of us resulting damage of the glass. Meanwhile some women armed with lathi, bamboo stick, and brickbats joined the mob to strengthen their demand. Some persons were found instigating and abetting the agitating people to continue the blocking of roads and not to cooperate with police. Some reinforcements were made by this time from adjoining PS areas to perform law and order duty and to assist. me to tackle the situation. I again requested the unruly people to withdraw road blockade and assured them to hear their grievances. But they were found more furious, adamant and stubborn over their demands. By this time the assembled unruly mob took some sticks on their hand and challenged police to face them. Under this circumstance I declared the assembly of people unlawful and commanded them to be dispersed but they became more violent and started pelting stones and brickbats aiming at Police indiscriminately following which one Lady Constable 119 Mayadebi Hembram, constable 1532 Meghnath Kar, Junior Constable 630 Dhananjoy Singha Mahapatra, constable 1345 Jitendra Nath Diasi, constable 847 Uttam Hajra, constable driver Rajib Choudbury, NVF 695 Tapan Munda and HG 1440 Sushil Kumar Hembram were severely injured out of which Dhananjoy Singha Mahapatra received head injury which could potentially be fatal. Having no other alternative way I had to arrest the aforesaid four accused persons from the spot and took initiative to disperse the assembly of the people from there using force. It is to be noted that when the above mentioned four accused persons were arrested from the spot while they were provoking the assembled mob into attacking the police party and while the arrested persons were being taken into custody and pushed inside the police van, a group comprising mostly of women like 1. Pastubala Gurikuta W/O Sraban Gurikuta of Sitijuri Majhpata PS Manhazar District Purulia 2. Smt Monibala Gurikuta W/O Mathan Gurikuta of Do 3.

District Purulia armed with lathi, bamboo stick, and brickbats assaulted the on-duty police party with a view to prevent them from taking the above mentioned four arrested accused persons into custody causing thereby disturbance and obstruction in the discharge of official work by the on-duty police men. Consequently chaos developed and one of the arrested accused persons received a blow and fell down causing some injury on left wrist. He was provided medical assistance at the earliest. Four munitions were burst to control the situation. The injured police personnel were also provided medical treatment at Manhazar hospital.

I, therefore, recorded Manhazar PS Case No. 21/17 dated 11.05.2017 U/S 147/148/149/186/353/427/332/333/307/109/114 IPC R/W Sec 18 West Bengal State Highway Act, 9 Maintenance of Public Order Act and 15A(b) West Bengal Maintenance of Public Order (Amendment) Act 2017 and directed SI Uttam Kumar Mondal to investigate the case.
