In producing here with accused Tarapada Bauri S/O Lt. Digambar Bauri of Village Deoli PS Neturia Dist Purulia, I beg to state that as per your kind order vide Neturia PS, GDE no-710 at 21:05 hrs dated 20/05/17, I along with force rushed to Deoli from D.Ghat where we were on evening mobile duty. I was directed by you to work out the information of an accident by a truck which caused damage of an electric pole at Deoli. When we just about to reach the spot I found approx 100-150 villagers started pelting stone towards our vehicle. We also found the villagers were armed with lathi, tangi, stone, BONTI (sharp cutting instrument to cut vegetables). We somehow got down from the vehicle and could save us more or less by hiding ourselves a little far from there. I have informed you over phone at about 21:30hrs and sought for help with additional Police force. At about 22:05 hrs. SI Nimal Cahandra Patra and his team reached there, then we came out from nearby bush and started moving inside the village with force. When we found few people seeing us started pelting stone again and started shouting to gather others, we rushed towards them with shouting. One person among them fell down, rest others could able to flee away and throwing stone towards us. By such stoning one C- 353 Baikya Nath Mukherjee, C-420 Sk. Chand, and I. ASI Bidhan Chandra Mondal got seriously injured. We could apprehend one person named as above at about 22:25 hrs. Since it was dark and cloudy night, more over there is no electric light at all on the spot, we decided to come back to PS with the injured persons as well as the detained person and the Govt. vehicle which got damaged by the villagers with stone and bricks. It also not worthy that owing to the darkness and the said event as above we could not find out any vehicle there which was reportedly involved in an accident. After return to the PS I interrogated the detained accused and could learn that accused Hiralal Bauri S/o not known, Samiran Bauri S/O Lt. Adhibas Bauri, Sandip Goswami S/O Dilip Goswami, Raja Bauri S/o Tarapada Bauri, Bharati Bauri W/O Tarapada Bauri, Manik Bauri S/o not known, Kanta Bauri S/o not known, Swapan bauri S/o not known, Fola Bauri S/o not known and 100/150 others including women and men were involved in the case. I found that the detained person was also injured for such pelting of stone by villagers. I have arranged to send the above police personnel as well as the detained accused to nearby Govt. hospital for medical treatment.

So, I pray before your goodness to start a specific case under proper section of law against accused 1. Tarapada Bauri S/O Lt. Digambar Bauri, 2. Hiralal Bauri, 3. Samiran Bauri S/O Lt. Adhibas Bauri, 4. Sandip Goswami S/O Dilip Goswami, 5. Raja Bauri S/o Tarapada Bauri, 6. Bharati Bauri W/O Tarapada Bauri, 7. Manik Bauri S/o not known, 8. Kanta Bauri S/o not known, 9. Swapan bauri S/o not known, 10. Fola Rajwar S/o not known all are resident of Village Deoli PS Neturia Dist Purulia and 100/150 others.
