Sir,

In producing herewith one ten (10) wheeler truck bearing Registration No. WB37 A-6346 fully loaded with Coal, I beg to state that on 20/05/17 at 21:05 hrs one information has been received vide Neturia PS GDE No. : 710 date 20/05/17 that a truck dashed one electric pole and damaged the electrical wiring at Deoli village. On the basis of such information, police rushed there for action but the villagers started pelting stone upon the police and injured police personals when police was about to reach to the spot. Thereafter with support of Additional police team, police team could bring the situation under control only by raiding and arresting one and returned to PS after searching and finding the truck not available there under consideration of the darkness and necessity of treatment for injured police personnel. Today at 12:25 hrs I alongwith CI, Kashipur, O/C, Neturia PS, other officers and forces of PS, Sub-divisional EF Line, R.N. Pur, O/c, Women PS and Lady constables left PS to hold Raid and investigation in C/W Neturia PS case no. : 58/17 date 20/05/17 U/S - 147/148/149/186/332/333/353 IPC and Section 3/4 of PDPP Act vide Neturia PS GDE No. : 740 dated 21/05/17 and CC No. : 1346/17. On reaching at Deoli village at about 13:05 hrs, we divided into two parts i.e. CI, Kashipur alongwith O/C Neturia and other officers and forces including lady constables started raid at Deoli village and as per direction of O/C Neturia PS I assisted SI Anirban Dutta and C/1119 Susanta Sinha, C/373 Abani Mahato, C/207 Ddip Paul and JC / 1251 Ratan Nayek for investigation of this case and searching of the vehicle. During search I found the above noted truck was parked beside the village road behind a bushy place at a turning point near the house of one Sandip Goswami S/O. Lt. Dilip Goswami of Deoli. Informed the matter to O/C and as per order I arranged to bring the said truck to PS and also enquired into the authenticity of its loaded materials and the ownership of the truck. During enquiry I found there was no claimant of the said truck and its loaded material (i.e. Coal) but it could be learnt that the coal has been procured by Sohoni Singh S/O Lt. Bhuneswar Singh of Parbelia Colliery New colony, P.S. - Neturia, dist - Purulia with the help of driver and the owner of the vehicle as above from the illegal stock of coal dealt with by one Vyas Yadav S/O Lt. Dharam Yadav of village Deoli - Veti Centre, P.S. - Neturia, dist - Purulia, A/P Amdanga Ashram under Neturia PS. It could also be learnt that such sort of illegal transaction / business has been continuing since long time using the village path by the above accused persons to evade police arrest and seizure. However I seized as follows - 1) One truck (Ten Wheeler) bearing Registration No. WB37 A-6346, red-white-sky blue in color, 2) Coal fully loaded in the above truck (Seized as Alamati in between 13:30 hrs and 14:15 hrs).

So I pray for starting a specific case against 1) The driver of the truck no. WB37 A-6346, 2) The owner of the truck no. WB37 A-6346, 3) Sohoni Singh S/O Lt. Bhuneswar Singh of Parbelia Colliery New colony, P.S. - Neturia, dist - Purulia (illegal transporter of coal) and 4) Vyas Yadav S/O Lt. Dharam Yadav of village Deoli - Veti Centre, P.S. - Neturia, dist - Purulia, A/P Amdanga Ashram under Neturia PS (illegal supplier of coal) under proper section of law.
