

Honorable Sir,

In producing herewith one arrested acid. person namely Bura Bhami 165 (196) 476 12. Moti Bhami of Vill. Charpatia, Ph. Para, District - Purulia with seized article i.e. 19 (nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure law.

I beg to submit that today (29.05.2017) during my mobile duty as well as constabulary between 19.25 hrs to 20.15 hrs acting on a tip off a raid was conducted in the cow shed adjacent the house of Bura Bhami 165 (196) 476 12. Moti Bhami of Vill. Charpatia, Ph. Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in cow shed. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 19 (nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each bottle contains 600 ml under proper seizure law in presence of witnesses duly signed by them and also arrested the above noted acid. person.

The above noted arrested acid. namely Bura Bhami 165 (196) 476 12. Moti Bhami of Vill. Charpatia, Ph. Para, District - Purulia committed offence u/s 46 A & 1 B.C.A. 1908 for unauthorized possession and sale of country spirit in his cow shed.

Under the above fact and circumstance I therefore pose that a case u/s 46 A & 1 B.C.A. 1908 mayably be started against Bura Bhami 165 (196) 476 12. Moti Bhami of Vill. Charpatia, Ph. Para, District - Purulia and arrange for its investigation.
