Respected Sir,

In producing herewith one arrested and one person namely Bura Bauri (65 yrs) s/o Lt. Mota Bauri of Vill- Charpatia, PS- Para, District - Purulia with seized article i.e. 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each bottle contains 600 ml in which 01 (one) bottle as sample which were seized under proper seizure list.

I beg to submit that today (29.05.2017) during my mobile duty as well as road duty in between 19.25 hrs to 20.15 hrs acting on a tip off a raid was conducted in the cow shed adjacent the house of Bura Bauri (65 yrs) s/o Lt. Mota Bauri of Vill-Charpatia PS- Para, District - Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in cow shed. On demand he failed to produce any valid document in respect of keeping and selling of said liquor. As such I seized 19 (Nineteen) pcs sealed bottles of Country Spirit styled as "DIL KHUSH" each bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted and person.

The above noted arrested and person namely Bura Bauri (65 yrs) s/o Lt. Mota Bauri of Vill-Charpatia PS- Para, District - Purulia committed offence u/s 46(A) B.E. Act, 1909 for unauthorized possession and sale of country spirit in his cow shed.

Under the above fact and circumstance I therefore pray that a case u/s 46(A) B.E. Act 1909 may kindly be started against Bura Bauri (65 yrs) s/o Lt. Mota Bauri of Vill-Charpatia, PS- Para, District - Purulia and arrange for its investigation.


