Sub: Request for lodging F.I.R. against accused Sunil Dutta s/o- Sankar Dutta of Paradih Majpara PS- Pancha Dist- Purulia u/s- 46A of B.E. Act 1909.

Sir,

In producing herewith seized articles viz. (i) 25 (Twenty five) Pieces Dil Khush Country Sprit per bottle 600ml I.A.S.I. Joydeb Gorai of Pancha PS do here by lodge complaint to the effect that today i.e. on 28/05/2017 at around 19.25 hrs. in course of my evening mobile duty at Pancha PS area received from Credible source information that one person namely Sunil Dutta of village Paradih is selling country sprit illegally and stored huge quantity of country sprit in his hotel Situated at Paradih bazar near Petrol Pump. Accordingly the above source information informed to O/C Pancha PS and as per his direction myself along with accompanying available forces had been to said place to work out the source information. At around 20.05 keeping our vehicle in a safe distance when we proceeded on foot to the Hotel of Sunil Dutta and found that the information is true. On seeing police personal the accused person namely Sunil Dutta fled way from the spot. During search and verification the above noted seized articles have been recovered from the Hotel and seized under proper seizure list in presence of witnesses namely (Santosh Duari S/O Late Madhab Duari of village Paradih Namo Para PS Pancha Dist. Purulia and (2) Sadhan Bouri S/O- Late Moriram Bouri of Paradih Bouripara, PS- Pancha, Dist. Purulia. I collect one Dil Khush bottle Country Sprit for sample and labeled properly.

Under the above fact and circumstance I pray before your good self that a specific case under proper section of law may kindly be started against the accused Sunil Dutta, S/O- Sankar Dutta of Paradih Maj Para, PS-Pancha, Dist. Purulia for its ~~regular~~ investigation.
