I do hereby lodge Complaint empowered

Potoni. P.S. Puncha Dist Purulia, has Committed theft of  
electricity (Amendment act 2007) on 16.05.2017 at 4.00 PM.  
I Sri Jagannath Kunder DE(O) Station Manager  
Puncha ccc alongwith (1) Sri Sandip Mahabo O.E S10  
dt. Baidaban Mahabo (2) Sukumar Dutta Sr. TSH both  
are attach to Puncha ccc. entered the premises of  
Sri Nanigopal Roy. 310dt Faribhusan Roy with Dumuria  
P.C. Potoni. P.S. Puncha Dist Purulia having Con. no. 242065  
772 Meter no B1464910 and inspected his premises.

During inspection theft of electricity was detected  
by bypassing the energy meter i.e. 4/3 135 I (A) was  
detected. The details of passing the arrangement was  
damage installation of the incoming wire and tap  
2 (two) size of wire by which electricity directly  
flow to his house without energy registration in  
WBS EDCI energy meter.

From the above bypassing system he uses  
the following equipment. i.e. fan-2nos, Lamp-2nos.  
& Plug point 01 etc.

out of which I seized the single core flexible cable 100 (hundred) feet with hooking device. Seizure list was prepared at the site and accused person signed. The inspection team left the premises at 4:30 PM on 16.05.2017. The accused person has committed an offence u/s 135 I (2) of electricity act 2003 subsequently electricity (Amendment) act-2007

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken as per rule.
