2. That the accused are members of a neighbouring village named village number 22.
3. That the accused took his son of poor character. The son is daughter of the complainant *Jyoti Devi* has been captured and kidnapped by the accused back off the son taken to her house. The son was found dead by the 17 days ago. It is known that his daughter has taken by the accused back from his initial vicinity without his knowledge and consent and without the knowledge and consent of any elderly member of the complainant.
4. That the incident of kidnapping happened when the complainant *Jyoti Devi* was unable from his home for more agricultural work.
5. That the complainant *Jyoti Devi* come to know the fact of kidnapping after coming back to home. The date of kidnapping was 20-06-2017.
6. That it is submitted by the complainant that he settled the marriage of her daughter on 20-06-2017 at village Dharaseli within Panchayat 22.
7. That the marriage of the daughter of complainant was settled to the complainant with one *Zakir Hussain Rajput* of village Dharaseli who is also name carrier but the accused had might have come to know the marriage of the complainant's daughter with said *Zakir Hussain Rajput* and become anxious and he alongwith the other two accused conspired together and despatched her to some other unknown place.
8. That the petitioner/complainant collected some information that his daughter might have taken either in the
