That the complainant is the resident of Chelyama, P.S.- Raghunathpur, Dist- Purulia, who is the proprietor of A. G. Civil Construction & General Order Supplier having Office and Godown at Hospital Road, Near Banda Primary Health Centre, Chelyama, P.S.- Raghunathpur, Dist- Purulia, W.B. within the jurisdiction of your Id. Court.

That routinely on 17/04/2017 at about 11:00 P.M. while the complainant was after maintain the office work, lock the office and godown and left for his house, and on the next day i.e. 18/04/2017, in morning, the complainant was informed by the witnesses no. i & ii, that there was a theft in his godown.

That the complainant reached his godown at about 6:00 A.M and found that there was a big hole in boundary wall of the godown, and found that the lock of the godown also broken.
