That the complainant most respectfully beg to state as follows:-

That the complainant is the resident of Chelyama, P.S. - Raghunathpur, Dist - Purulia, who is the proprietor of A.G. Civil Construction & General Order Supplier having Office and Godown at Hospital Road, Near Bandra Primary Health Centre, Chelyama, P.S. - Raghunathpur, Dist - Purulia, W.B. within the jurisdiction of your id. Court.

That routinely on 17/04/2017 at about 11:00 PM while the complainant was after maintain the office work, lock the office and godown and left for his house, and on the next day i.e. 18/04/2017, in morning, the complainant was informed by the witnesses no. 3 & 4, that there was a theft in his godown.

That the complainant reached his godown at about 6:00 AM and found that there was a big hole in boundary wall of the godown, and found that the lock of the godown also broken.

That the complainant found that several articles/materials more specifically described in below, has been thefted by the miscreants.

5. That the articles/materials theft are the insured articles, and for informing the concerned authority about insurance, the complainant immediately went to Raghunathpur Police-Station on 18/04/2017, to lodge the written complaint, where the concerned authority of police station are not willing to receive the written complaint, and if the FIR will not recorded within 24 hours of incident and same has not been informed to the insurance authority with copy of FIR, then the complainant will suffer irreparable loss, though same are the insured articles.
6. That the insurance company will not grant any relief, if the above noted matter will not be treated as FIR within 24 hours from the incident.
7. That the complainant due to urgency for the redressal of his grievances, made the instant application before your ld. Court, and has not send any application before the Superintendent of Police, Purulia, under section 154(3) Cr.P.C about the refusal of application by the concerned police station.
