Sub: Lodging of FIR.

Respected Sir,

In producing herewith two arrested acid persons namely 1) Nilbaran Orang (Rt) S/O- Lt Shashibhutan Orang, 2) Sanjib Orang (Rt) S/O- Lt. Kalyanwarad Orang both of Santalal, PS- Santalal, dist. Purulia alongwith seized article (1) 1/2 (1/2) pieces of small round metal 200gm each, 2) one uniform full part of ASI Santalal Ex. Singh, 3) 02 (two) pieces of Ballam, 4) Lt Keshab Chatterjee do hereby lodged a written complaint as See motto to the effect that faculty (11.5/17) at 05.45hrs received information that some local people of Santalal village have locked the main gate of Santalal P.S. School to restrain the normal work of school. As per order of IC Santalal PS, Mysell along with officers, having including Lt. Kalyanwarad S/O- Lt. no. 842/17 left for Santalal village to peruse the information. At around 06.30hrs we reached at Santalal P.S. School. We found the school in lock condition. The IC of the school namely Ashoke Chakrabarty informed that some local people have locked the same forcefully. Some unlawful assembly were assembled around the school. I and other officers requested the unlawful assembly present there to open the school through public address system repeatedly but they did not pay any heed to that. Police then tried to open the school with the help of Teachers. By that time the unlawful assembly including female 100 in numbers with iron, laths, ballam started to attacked the police party. The Unlawful assembly restrained the police and the teacher to open the school. The miscreants then started to throw stones along the police party causing serious injury of 06 police persons at random. They kept the female persons in front side and the male persons were throwing stones to police. Police requested them to maintain order repeatedly but they became more violent. To disperse the unlawful assembly as per direction C/737 Haradhar Nayak of Santalal PS fired 08 rds of tear gas (LR-4, LR-4) from govt gas gun side but no-11 with a view to defend us and also to protect govt arm and ammunition and other govt. property I arrested two persons from the PD during action namely 1) Nilbaran Orang S/O- Lt Shashibhutan Orang, 2) Sanjib Orang S/O- Lt. Kalyanwarad Orang both of Santalal, PS- Santalal, dist. Purulia. Other miscreants disperse from that place. Police personnel namely SI Aji K. Mishra, ASI Santalal Ex. Singh, ASI Soanem Ex. Panda, C/1261 Sanil Goswami, C/737 Haradhar Nayak, C/452 Gouram Roy, sustain serious injury on their persons. They treated at SPS Hospital and injury reports were prepared by MO on duty. During arrest of Sanjib Orang, he tried to escape attacking the police so, minimum force was applied to secure his arrest. During local enquiry, I came to know that approx 100 people including female under the leadership of 1) Nilbaran Orang S/O- Jagannath Orang, 2) Anil Orang S/O- Palhan Orang, 3) Sanjib Orang S/O- Lt. Kalyanwarad Orang, 4) Nilbaran Orang S/O- Lt. Shashibhutan Orang all of Santalal, PS- Santalal, dist. Purulia unlawfully assembled there to restrain normal work of the Primary School. The others members of that unlawful assembly who took active part and identified as 1) Balaram Orang S/O- Shantiram Orang, 2) Sanjoy Orang S/O- Palhan Orang, 3) Bholaiah Orang S/O- Gohiran Orang, 4) Debanand Orang S/O- Anil Orang, 5) Gaja Orang S/O- Hirajal Orang, 6) Ashoke Orang S/O- Tropol Orang, 7) Burubal Orang S/O- Kalicharan Orang, 8) Dehial Orang S/O- Chutul Orang, 9) Shaktipada Orang S/O- Chutul Orang, 10) Joydeb Orang S/O- Ramhari Orang, 11) Uttam Orang S/O- Bahubari Orang, 12) Raja Orang S/O- Surendra Orang, 13) Aruni Orang S/O- Shantiram Orang, 14) Kamal kanta Orang S/O- Haru Orang, 15) Haru Orang S/O- Anil Orang, 16) Parikshit Orang S/O- Sitaram Orang 17) Saraswati Orang S/O- Sanjib Orang all of Santalal, PS- Santalal, dist. Purulia and others including females.

I, therefore, submit that a case may kindly be started against the above noted acid persons and others under proper section of Law and arrange for its investigation.
