Respected Sir.

In producing here with arrested accused persons namely (1) Sk. Safik (30yrs) S/O-Lt. Sk. Rajjak.

(2) Sk. Kadir (30yrs) S/O-Lt. Sk. Biraj and (3) Joydeb Roy (22) S/O-Tarapada Roy all are of Vill-Bajkar Tanr. PS-Para, Dist-Purulia along with seized one improvised country made Fire Arms, one crewher, one cutiass, one rod, one bambos stick, I beg to lodge this complaint against the said arrested accused persons and his associates (1) Fatick Sk. (Approx 55yrs) S/O-Lt. Rasul Sk. of Vill-Bajkatra, PS-Para, Dist-Purulia (2) Ashim © Wasim Sk.(Approx 40yrs) of Vill-Bajkar Tanr[Dangapara], PS-Para, Dist-Purulia who were manage to fied away to the effect that today at about 18:15 hrs I received a credible source information that a gang of dacoits assembled at the back side area of a under construction building at Poradiha More which situated just beside the Saltora – Sarbari road. He also informed me that they are preparing themselves for committing a dacoity at "Poradiha Bharat Petrol Pump". Accordingly, I noted the fact in G.D. vide Santuri P.S. GDE No. 409/17 Dtd: 10:85.17 and informed the matter to O/C Santuri P.S. Thereafter, I called the E/P party (A.S.I. Narayan Mukherjee, C/157 Dipak Bouri, C/716 Achintya Majee, CD/1258 Santanu Manna) and additional force C/597 Nishanath Mukherjee left P.S. to work out the taid source information after obtain permission from O/C Santuri P.S. vide Santuri P.S. C.C. No. 1835/17 Dtd: 10:05.17 by Govt, vehicle bearing No. WNF/1225.

Then, we stopped our vehicle by the side of road keeping approx 100 meters distance from Poradiha More. After that, we gradually approached at the back side area of said under construction building (place of assembly of the criminals) as indicated by the source hiding ourselves in the darkness of the bushes and avoiding any type of sounds. We slowly and carefully advanced nearer to the spot taking advantage of the darkness of the bushes from where miscreants were clearly visible and their whispering also audible to us. We noticed that they were preparing themselves to commit a darnity at "Poradiha Bharat Petrol Pump" under Santuri PS. After approaching towards them from a considerable distance, we confirmed that a gang of 05 (five) miscreants assembled there and making preparation for committing darnity in the said Petrol Pump at night. Thereafter, we quickly surrounded the place of assemble from all the side and loudly disclosed our identity. Accordingly, they started to run but after a but chase we manage to apprehend 03 (three) miscreants out of 65 (five) miscreants. As such there is no locality nearby, we failed to bring any public witness.

Then, I interrogate them one by one where they disclosed their identity as noted above and also confessed that they were really assembled there for making preparation with a view to commit datoity at the said Petrol Pump being armed with Fire Arms and other offensive weapons. During interrigation, they disclosed the name of 02(two) other associates as (1) Fatick Sk. (Approx 55yrs) 5/0-Lt. Rasul Sk. of Vill-Bankatara, PS-Para, Dist-Purulia (2) Ashim @ Wasim Sk.(Approx 40yrs) of Vill-Bankar Tanr(Dangapara), PS-Para, Dist-Purulia who were manage to fled away. Accordingly, I arrest them after prepared proper arrest memo and after observed all the rules &norms of arrest. Then, we started to search each criminal one by one and recovered the following offensive articles from their exclusive and respective possessions as described below;-

- 6. One improvised iron made country made fire arms fitted with Butt, Body, Barrel, Trigger, Firing Pin, having length 22.5 cm (approx), Butt to Body 12.5 cm (approx) and Barrel 14.5 cm (approx) which recovered & seized from the exclusive possession of accd. Sk. Safik found kept conceal inside the part at waist position.
- One Crowbar having length of 66 cm (approx) seized from the exclusive possession of accd. Sk. Kadir.
- One true made Cutlass having length of 38.5 cm (approx) including 15 c, (approx) handgrip scited from the exclusive possession of accd, Joydeb Roy found kept conceal inside the part at waist position.

Then, we asked them to produce the valid license or documents in respect of possessing and carrying such fire arms as per provision of Arms Act-1959 but all of them failed to produce any valid license or documents in respect of carrying and possessing the fire arms. Hence, it is reason to believe that they were possessing and carrying such fire arms illegally for offensive work. Hence, I seized all the same as noted above after prepared proper seizure list duly signed by the witnesses and accd, persons after making proper label.

Apart from that I seized the following articles as Alamat of this case-

- i. One iron made rod having length approx 109 cm.
- ii. One Bamboo stick having length approx 100cm.

All the above noted articles have been seized under proper seizure list duly signed by the witnesses and accused persons. The process of search, arrest and seizure commenced at 19:25 hrs and completed at 20:35 hrs.

I like to note here that during arrest all the arrested accused persons were well informed regarding cause of arrest, copies of arrest memo & seizure list has been supplied to them.

The above noted arrested accused persons and their associates were came there with unauthorized improvised fire arms, Crowbar, Cutlass, iron rod & bamboo stick for committing dacoity at "Poradiha Bharat Petrol Pump" and they liable U/S 399/402 LP.C. read with sec. 25(1-A)/27/35 Arms art.

So, kindly start a case against all the above noted 05 (five) accused persons -(1) Sk. Safik S/O-Lt. Sk. Baijak. (2) Sk. Kadir S/O-Lt. Sk. Biraj. (3) loydeb Roy S/O-Tarapada Roy. (4) Fatick Sk. S/O-Lt. Rasul Sk., all are of Vill-Bajkar Tanr. PS-Para, Dist-Purulia and (5) Ashim @ Wasim Sk. of Vill-Bajkar Tanr. (Dangapara), PS-Para, Dist-Purulia and arrange its investigation.
