Dear Sir,

I do hereby lodge complaint empowered by enabling the electricity act-2003 subsequently electricity (Amendment) act- 2007 to the effect that Basudev Das was tampering electricity unauthorizedly by bypassing of energy meter by cutting of incoming service cable and due to this reason he has committed theft of electricity U/s 135 of the electricity (Amendment) act- 2007 on

Entered the premises of Basudev Das Vill Goosika  
P.S. Santuri Dist- Purulia, bearing Consumer No. 20160.9224 Meter No. AR277062

and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. US135(1/16) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in WBSEDCL energy meter.

From the above by-passing system inside were the following electrical equipments.

- 1) Color TV - 01 no (8000)
- 2) Electric Bulb (100W) - 02 nos.
- 3) Electric Pump (5700) - 01 no.
- 4) Electric Fan (600) - 02 nos.

Out of which I seized the following

PVC 2 core service cable with bypassing arrangement - 3ft. (approx).

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection team left the premises at 1.40 PM on 25/05/17. The accused person has committed an offence U/S135(1/16) of the electricity act-2003 subsequently electricity (Amendment) act- 2007.

You are requested to take cognizance of this complaint & treat it as F.I.R. and action may be taken as per rule.
