Dear Sir,

I am hereby advise a complaint which was received by enabling the Electricity Act 2003 (Amendment) Act-2003 to the effect that Sri Pravin Mohan, C/O Mahendranath Mohan, VII + PO- Mahe, Dist-PULWAMA has committed theft of Electricity u/s-13(1)(a) of the Electricity Act 2003 (Amendment) Act-2003

On dated 21.06.2017 I received a secret complaint over telephone that Sri Pravin Mohan, C/O Mahendranath Mohan, VII + PO- Mahe, Dist-PULWAMA consuming electricity by means of direct hooking by nearest LT Pole

On the basis of said complaint at about 01:05 pm, I, Sri Minimal Chowdhury, Assistant Engineer & District Manager Kashmir Customer Care Centre, W&MDC, along with,

- 1) Sri Dipak K. Shrivastava, SAE, Kashmir C.C.C.
- 2) Sri Sanjay Kumar, CE - Kashmir C.C.C.

Entered the premises of Sri Pravin Mohan, and found that he is consuming electricity dishonestly by means of direct hooking by nearest LT Pole. Though there is permanent connection in the same premises. Total load found approx 0.5 KW (which has 2 nos. TL 2 nos. are disconnected by hooking line along with the permanent connection

We seized the following articles:

- 1) hooking wire with hooking device approx. 25 ft.
- 2) Tools with material etc.

After preparation of proper seizure list the seizure list are prepared at the site and the representative of accused person refuse to sign in the seizure list. The inspection team left the above premises at about 07:35 pm. The accused person has committed an offence u/s-13(1)(a) of the Electricity (Amendment) Act-2003 for illegal theft of electricity

You are requested to take cognizance of the complaint and treat it as a crime and action may be taken as per law.
