Sir,

In producing herewith one arrested accused namely Shekh Nasim(27),s/o-Shekh Najir of Tajnagar, Kopali Dobo, PS-Chandil, Dist-Saraikella-Kharswan, Jharkhand with Arrest Memo, seizure list, other related papers and seized articles such as one iron made single bore country made firearms having length of 26cm (approx) with butt, barrel, firing pin, trigger etc. The length of the barrel is 15 cm (approx) and one live ammunition of 8 mm under proper seizure list and being labeled properly, I beg to inform you that today (30/07/17) during my evening mobile duty at Arsha PS area vide Arsha PS CC No-2116 Dtd-30/07/17 & GDE No-1013 Dtd-30.07.2017 at 19:15 hrs received a telephonic information from my reliable source that one youth aged about 27 years was seen loitering at Satra more under Arsha PS and a careful observation from the close point of view something like the butt of a small firearms was seen at his waist being kept supported with his pant and it was his firm belief that it was nothing but a fire arms . I asked him to keep eye upon the suspicious person and consulted with O/C Arsha PS over telephone about this matter and as per his direction at 19:25 hrs, I along with C/37-Durjan Murmu of Arsha PS, C/211-Avijit Gorain of SAP 7th Bn now camp at Arsha PS started for working out the information from Hensla more after briefing them properly about the gravity of the information and my plan to nab him. We reached at Satra more at around 19:45 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching there, my source identified the person by gesture from a distance and we apprehended one youth and on asked he identified himself as Shekh Nasim(27),s/o-Shekh Najir of Tajnagar, Kopali Dobo, PS-Chandil, Dist-Saraikella-Kharswan, Jharkhand and I disclosed him about the information and on searching one iron made single bore country made fire arms having length of 26cm (overall approx) with butt, barrel, firing pin, trigger etc has been found. The length of the barrel is 15 cm (approx) and was recovered from his exclusive possession and on opening the fire arms one live ammunition of 8 mm was recovered as being loaded in the fire arms. On asked he failed to produce any constitutional papers in support of possessing or keeping the fire arms. I took a pictorial diagram of the said firearms in presence of accused person and then I seized the above narrated firearms and ammunition from his possession under proper seizure list and also labeled them separately, but no public witness could be made available there at night. After seizure I arrested him at 20:45 hrs observing all the formalities regarding arrest as his offense comes under the purview of Indian Arms Act.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
