Sub-Prayer for starting a specific case against namely Rufik Hembram(28), s/o-Bharat Hembram of vill-Kolabani, PS-Arsha, Dist-Purulia.

Sir,

In producing herewith one accused person namely Rufik Hembram(28), s/o-Bharat Hembram of vill-Kolabani, PS-Arsha, Dist-Purulia under arrest and the following seized articles under seizure list enclosed herewith:

- 1) Fifteen (15) sealed bottles (CS) containing 375 ml each and labelled with DILKUSH
- 2) Ten (10) sealed plastic bottles (CS) containing 600 ml each and labelled with DILSE
- 3) Cash Rs-155/- (One hundred and fifty five only)
- 4) One yellow nylon bag.
- 5) One white big polythin bag.

I ASI Jaydev Atta of Arsha PS do hereby lodge this complaint regarding that today 16.07.17 at about 15.25 hrs during my mobile duty at Aharrah more received source information over telephone that the above noted accused has been selling illegal liquor illegally and clandestinely at Joltanki more under Sirkabad village right side of Aharrah-Sirkabad road under Arsha PS. On receiving the reliable source information I communicated with O/C Arsha PS over telephone and as per his instruction I along with C/646-Loharam Ghosh, C/254-Animesh Pathak of SAP 7th Bn camp at Arsha PS rushed to the spot to work out the information. On arriving to the spot at 15.35 hrs I apprehended the above noted person after a strong attempt and one customer seeing the Police party managed to escape. On close interrogation that apprehended person had disclosed his name & address as noted above. I asked him to produce any valid paper in support of selling that illicit liquor but he failed to produce any legal paper or document in support for selling such liquor. Accordingly I seized all those noted above after preparing proper seizure list and labelled the seized articles duly signed by the accompanying party in the seizure list and the label. After this I arrested that accused person namely Rufik Hembram(28), s/o-Bharat Hembram of vill-Kolabani, PS-Arsha, Dist-Purulia after preparing proper memo of arrest.

Under the above facts & circumstances I pray before your honour that a specific case may kindly be started against the said accused person under proper section of law and arrange for investigation.
