In producing herewith one accused person namely Ajay Mahato(45)s/o-L1 Kalicharan Mahato of vill-PO-Hetgugui,PS-Arsha, Dist-Purulia along with one(01) seized Motorcycle as per above noted accused person to the effect that on 25.07.17 at 16.25 hrs receive a credible source information from my reliable source that one Ajay Mahato(45)s/o-L1 Kalicharan Mahato of vill-PO-Hetgugui,PS-Arsha, Dist-Purulia engaged in the business of stolen motorcycles at present accumulated some stolen motorcycles at his tea shop village-Hetgugui, PS-Arsha, Dist-Purulia. This reference Arsha PS GDE No-Dtd-826 Dtd-25/07/17. To work out the source information I SI Arup Kr Ayan Kr Mondal, C/343-Avijit Patra both SAP 7th Bu camp at Arsha PS vide Arsha PS C.C No-2068 Date-25/07/17 & held raid in the tea shop of accused Ajay Mahato(45)s/o-L1 Kalicharan Mahato of vill-PO-Hetgugui,PS-Arsha, Dist-Purulia at 17.15 hrs. On searching his tea shop we found one (01)motorcycle noted below and asked him to produce the relevent documents in respect of following motorcycle but he failed to produce any valid documents in respect of the following motorcycle and during interrogation he clearly confessed that he along with Bikash Karmali @ Sahil S/o-Santosh Karmali of Gorla village, PS-Jhalka, Dist-Purulia, A/P-Kedla, No-15 Colliery, PS-Mandu, Dist-Ramgarh (Jharkhand) & others habitually deals with the business of stolen motorcycles in a clandestine manners from last few years. I seized the following motorcycle after preparing proper seizure list duly signed by accused person and accompany Police persons because the local people refused to sign in seizure list.


1) One Hero Passion Pro M/C (Black clour) having Engine No.-HA10ENE1HG74600, Chasis No-MBLHA10A6EHG49602 and Reg. No-JH01AZ/2850.

Then I arrested accused Ajay Mahato(45)s/o-L1 Kalicharan Mahato of vill-PO-Hetgugui,PS-Arsha, Dist-Purulia after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with all 01 seized motorcycle.


Therefore I pray that a specific case may kindly be registered against the above noted accused person/under propers section of law.
