This refers Baghmundi P.S. CR No. 107 Date: 08.07.17. To work out the source information I myself along with force namely D C 178 Shyamnada Lohar II C 018 Swapan Kr Das III C 001 Shyamsal Mandi etc. Baghmundi P.S. CC No. 2877/17 DTD 08.07.17 held raid in the house of Sadhu = Shambhu Karmakar = Lohar (Male/35 Years) SO Late- Kripashindhu Karmakar of Vill -PO- Gobindapur, PS- Baghmundi, Dist-Purulia. On searching we found 04 Motor Cycles and 02 Scooty and asked him to show the relevant papers of our Motor Cycles and Scooty, but he failed to produce any valid documents in respect of these motor cycles and Scooty and during interrogation he confessed that he along with one Rakesh Karmah of Kofla, Rangarb, JKD habitually deal with the business of stolen motor cycles in a clandestine manner last 04 years. I seized the following Motor Cycle through proper seizure list in presence of available witnesses:-

I registered the case Sumarto US- 413/11 IPC against arrested Sadhu = Shambhu Karmakar = Lohar (Male/35 Years) SO Late- Kripashindhu Karmakar of Vill -PO- Gobindapur, PS- Baghmundi, Dist-Purulia and endorsed the case to 1st Senior Bazarwa for investigation and handed over all connective papers in case this case i.e. Arrest Memo, Seizure List etc. along with seized articles.
