





- the complainant on 25th day of July 2014 which has been authenticated before Notary Public wherein the said accused person and the complainant agreed that if the complainant would be provide the job for premature death of Murulidhar Paul in that case will retain 70% of the salary of the rest 30% in each month to be given to the said accused person on the other hand if the accused person be provided the service in that case he will retain 70% of said amount and rest 30% be given to the complainant. It is also agreed that the other debts and dues including P.F., Pension gratuity etc and other benefits be disbursed 50% each.
- that the accused person would be provided the service in that case the accused person will pay 30% of the salary amount to the complainant in each month and thereafter in due course the accused person has joined in his service on 12.1.15, but he did not pay any of amount from his salary much/less 30% and also not given any share of money which the complainant is entitled to get 50% thereof.

- That the complainant is in distress condition as the husband of the complainant died on 20/10/2011 and is in fully dependent upon the income of the accused person and for want of money etc the complainant is living in half fall and not in a position to maintain herself even not in a position to arrange two square meal along with other daily necessities.
- That the accused person before joining his service he used to maintain the complainant also entered in to the said Agreement and agreed to maintain me by providing 30% of the salary amount per month and also provided 50% of the amount lying with the Department. But the accused by violating his previous agreement did not keep his word by not providing any amount to the complainant
- fraudulently and dishonestly induced the complainant and obtained her consent for alleging the accused to be appointed of the service of Murulidhar Paul and also by get taking that the complainant as per agreement and the complainant causing monetary loss to the complainant and gain to the accused person and accordingly the accused person also damaged and harm to body and mind in respect of the family and that accuse is thereby cheated the



complainant and that the accused person also have committed criminal breach of trust and also committed other offences publishable under the Indian Penal Law for which he is deserve to be publishable under the law.

That the accused person threatened the complaint and due to fear the complainant lodged one complaint before the Officer in-charge Bagmundi for taking appropriate legal action against the accused persons but due to inaction of the Police of Bagmundi P.S. the complainant lodged another complaint to the Superintendent of Police Purulia but same fate. Hence the complainant is under compelling circumstance filed this complaint before this Ld. Court under the law.

In the circumstances it is therefore, prayed that your honour may be pleased to send the petition of complaint to the Officer-in-charge, Bagmundi P.S. treating the same as FIR under section 156(3) for investigation.
