I do hereby lodge complaint empowered by enabling The Electricity Act-2003, subsequently Electricity (Amendment) Act-2007 to the effect that Molka Borey, No 4 Shree Majhi of village Bara Chaturma (Shalbagan), P.S. Balarampur is enjoying electricity illegally by way of direct hooking from the nearby LTCH line of WBSEDCL & he has committed theft of electricity U/S 135 of The Electricity (Amendment) Act-2007.

Entered the premises of Molka Borey, No 4 Shree Majhi of village Bara Chaturma (Shalbagan), P.S. Balarampur, Dist - Purulia

and inspected his premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of W.B.S.E.D.C.L. i.e. U/S 135 (f) (a) was detected.

From the above arrangement he/she was using the following electrical equipments:

- 1) Lamp 100 watts - 1 no.
- 2) Lamp 10 watts - 1 no.
- 3) LED Lamp 5 watt - 1 no.

of which I seized the following

- 1) Lamp 100 watts with holder & 3 pin key type switch - 1 no.
- 2) Single core live insulated Aluminium wire with hooking device - 1/20m (approx)
