I do hereby lodge complaint empowered by enacting The Electricity Act-2003,
subsequently Electricity (Amendment) Act-2003 to the effect that Motika Banerjee, 3/o & Shikha Majhi
resides at ~~Balarampur~~, via Barn Chaburma (Shaburma), l.s. Balarampur is enjoying
electricity illegally by way of direct hooking from the nearby L.T.O.H line of WBSEBCL & he
has committed theft of electricity U/S 135 of The Electricity (amendment) Act-2003.

Entered the premises of Motika Banerjee, 3/o & Shikha Majhi at via-Barn Chaburma
(Shaburma), l.s. Balarampur, Dist- Purulia

and inspected his/her premises. During inspection theft of electricity was detected i.e. he/she
was using electricity dishonestly by/using illegal hooking from the nearest L.T.O.H line of
WBSEBCL i.e. U/S 135 (I) (a) was detected.

From the above arrangement he/she was using the following electrical equipment:

- 1) Lamp 100 watts - 1 no.
- 2) Lamp 60 watts - 1 no.
- 3) LED Lamp 5 watt - 1 no.

of which I seized the following

Lamp 100 watts with holder & 1 binary type switch - 1 no.
Single core pre insulated aluminium wire with heating device - 1.00m (approx.)

Seizure list was prepared at the site and accused person refused to sign/initial on the seizure list.

The inspection team left the premises at 3.10 PM on 16.07.2017.

The accused person has committed an offence U/S 135 (I) (a) of The Electricity Act-2003 &
