Respected Sir,

In producing here with one arrested accused person namely Chandan Saw S/O- Thakur Saw of Vill.- Tata Road Balarampur, P.S.- Balarampur, Dist. Purulia along with seized 35 (Thirty five) sealed country sprit bottles (DIL KHUSHI) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 20.05 hrs I received a credible source information that one person namely Chandan Saw S/O- Thakur Saw of Vill.- Tata Road Balarampur, P.S.- Balarampur, Dist. Purulia is selling country sprit without any valid license from his own line Hotel near Amruhanasa bridge under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Line Hotel near Amruhanasa bridge to work out the source information and held raid in Line Hotel of accd. person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his Line Hotel. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and label sample bottles. Total 35 (Thirty five) bottles country sprit has been seized, total value of the said seized sprit is Rs-1050/- (One thousand & fifty only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Chandan Saw S/O- Thakur Saw of Vill.- Tata Road Balarampur, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
