Sir,

In producing herewith one accused person namely Jiten Hansda (28 yrs) S/O- Lt. Ananda Hansda of Parogora, P.S.- Balarampur, Dist.-Purulia along with 08 (eight) seized Motorcycles as per seizure list. I ASI Santosh Roy of Balarampur PS lodged a complainant against the above noted accused person to the effect that on 19.07.17 at 18.05 hrs receive a credible source information from my reliable source that one Jiten Hansda S/O- Lt. Ananda Hansda of Parogora, P.S.- Balarampur, Dist.-Purulia engaged in the business of stolen motorcycles at present accumulated some stolen motorcycles at his house village Parogora PS-Balarampur Dist-Purulia. This reference Balarampur PS GDE No-835 Dtd-19/07/17. To work out the source information I ASI Santosh Roy along with force 1)JC/377 Arjun Yadav 2) JC/378 Palash Mukherjee 3) JC/1175 Ratnakamal Saha 4) JC/395 Tapas Dandapat 5) NVF/509 Kshetra Nath Mardana 6) HG/1556 Ashok Gorai vide Balarampur PS C.C No.-3860 Date-19/07/17 & held raid in the house of accused Jiten Hansda on searching we found 08 motorcycles and asked him to produce the relevent documents in respect of following motorcycles but he failed to produce any valid documents in respect of the following motorcycle and during interrogation he clearly confessed that he along with the Hriday Kumar @ Hutu Kumar S/O- Ketap Kumar of Hutu, P.S.- Nimdih, Dist.- Saraikella Kharswan (Jharkhand) habitually deal with the business of stolen motorcycles in a clandestine manners from last few years. I seized the following motorcycles after preparing proper seizure list duly signed by accused person and accompany Police persons because the local people refused to sign in seizure list.

- 1) One Hero Honda CD Deluxe M/C (Black clour) having Engine No.-IS3497CMGBB, Chasis No-MBLHA11ERC9F00525 and Reg. no.-JH05AP/7139
- 2) One Hero Honda Super Splender motor cycle (Blue) having Engine No-IS3497CM³GBG Chasis No.-05LAAF05931 and Reg. No-WB56F/1948
- 3) One Hero Honda CD Deluxe motor cycle (Red) having Engine No-PM1397CMGBS Chasis No.-07J02F04101 and Reg. No.-WB56C/6974
- 4) One Hero Honda Splender (Blue) motor cycle having Engine No-IS697CMGBG Chasis No.-03A20C09244 and having Reg. No-JH05E/2814
- 5) One Hero Passion Pro (Black) motor cycle having Engine No-IS2097CMGBGR188, Chasis No-MBLHA10AWCHH3145 and Reg. No not noted.
- 6) One Hero Honda Passion Pro (White) motor cycle having Engine No.-IS1497CMGBG Chasis No-MBC8A10AKAGM05842 and Reg. No.-JH05A/4026
- 7) One Hero Honda CD Deluxe (Black) motor cycle having Engine No-IS397CMGBG Chasis No.-07J02F31155 and Reg. No. WB56F/7837
- 8) One Hero Honda Passion Pro (Black) motor cycle having Engine no-PM2297CMGBGR188 Chasis No.-MBLHA10BJEHH05976 and Reg. No.-JH05B/4766

I arrested accused Jiten Hansda S/O- Lt. Ananda Hansda of Parogora, P.S.- Balarampur, Dist.-Purulia after explaining ground of arrest and observing all formalities regarding arrest and brought to PS along with all 08 seized motorcycles.

Therefore I pray that a specific case may kindly be registered against the above noted accused person under proper section of law.
