Sub: Complaint against Mihir Mandal (44 yrs) S/O- Lt. Gour Ch. Mandal of Vill.- Hetyadih, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C) B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Mihir Mandal (44 yrs) S/O- Lt. Gour Ch. Mandal of Vill.- Hetyadih, P.S.- Balarampur, Dist. Purulia along with seized 32 (thirty two) sealed country spirit bottles (Dil KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:35 hrs I received a credible source information that one person namely Mihir Mandal S/O- Lt. Gour Ch. Mandal of Vill.- Hetyadih, P.S.- Balarampur, Dist. Purulia is selling country spirit without any valid license from his own tea shop at village Hetyadih under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for village Hetyadih to work out the source information and held raid in tea shop of accd. person.

During search with the help of accompany force, we found that the said person is selling country spirit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country spirit. Accordingly, I arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country spirit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 19 (nineteen) liters & 200 ML country spirit has been seized, total value of the said seized spirit is Rs- 960/= (nine hundred & sixty only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C) B.E. Act against the arrested accused person namely Mihir Mandal S/O- Lt. Gour Ch. Mandal of Vill.- Hetyadih, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
