Sir,

I am hereby lodge complaint, empowered by enacting "The Electricity Act, 2003" subsequently electricity act-2007, so the effect that AKUL PARAN MAHATO S/O LT. MATHUR MAHATO of VII- TAKARA, P.S- Barabazar, Dist- Purulia was enjoying electricity unlawfully by illegal hooking from nearest L10N line with the help of two Core Flexible PVC cable for running his Poultry Farm and he has committed theft of electricity u/s 135(1)(b) of the electricity (Amendment) act-2007.

On 04.07.2017, I Sri SUBAL CH. DEY, D.E & S.M., BARABAIZAR CCC along with:

- (1) SAMAR KUMAR PANDEY, Recd. DSP, S&I P, PURULIA REGIONAL OFFICE, WBSEDCL
- (2) AMIT SINGH, A.F.O (S/O SANJAY SINHA), VILL. GOKSHA, P.S - BHIMBERA, DIST- PASCHIM MEDINIPUR
- (3) JAGADDEEPRAKASH SINGH, S/O LT. MADHUSUDAN GHOSH, VILL. BHAKURDH, P.S- KATWA, DIST- BURDwan

At About 2:00 P.M., entered into the Poultry Farm of AKUL PARAN MAHATO S/O LT. MATHUR MAHATO of VII- TAKARA, P.S- Barabazar, Dist- Purulia and inspected his Farm at VII- Takara, P.S Barabazar, Dist- Purulia.

During inspection, it was found that AKUL PARAN MAHATO S/O LT. MATHUR MAHATO of VII- TAKARA, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally by illegal hooking from nearest L10N line with the help of two Core Flexible PVC cable in his Poultry Farm at Takara having connected load 0.47 KVA.

From the above arrangement he was using the following equipment:

01. Two core flexible PVC cable (15 mt. Approx) with hooking device.
02. 04 Nos. of Lamp (200 watt each)

Out of which I seized the following articles:

1. Two core flexible PVC cable (15 mt. Approx) with hooking device
2. 01 no. of Lamp (200 Watt)

Seizure list was prepared at site. After process of inspection and seizure list we left the premises at about 02.15 p.m.

The said person has committed an offence u/s 135(1)(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
