Respected Sir,

In producing here with one arrested accused person namely Lal Mohan Mahato (30 yrs) S/O- Parikshit Mahato of Shyamnagar, P.S.- Balarampur, Dist. Purulia along with seized 30 (thirty) sealed country sprit bottles (DIL KHUSH) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 18:15 hrs I received a credible source information that one person namely Lal Mohan Mahato S/O- Parikshit Mahato of Shyamnagar, P.S.-Balacampur, Dist. Purulia is selling country sprit without any valid license from his own tea stall at village Shyamnagar under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for village Shyamnagar to work out the source information and held raid in the tea stall of acod, person.

During search with the help of accompany force, we found that the said person is selling country sprit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country sprit. Accordingly, I arrested him after preparing peoper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him. Then, I seized all the sealed country sprit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample bottles. Total 18 (eighteen) liters country sprit has been seized, total value of the said seized sprit is Rs-900/= (nine hundred only).

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C|B.E. Act against the arrested accused person Lal Mohan Mahato S/O- Parikshit Mahato of Shyamnagar, P.S.-Balarampur, Dist. Purulia and arrange for its investigation.
