Sir,


In producing here with arrested accused namely Barani Mahato (30 yrs) s/o late Raban Ch. Mahato of Village Bahandih PS Hura Dist. Purulia along with seized Country Spirit bottles (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 16.07.17 in between 19.35 to 20.05 hrs acting on a credible source information I SI Bablu Ghosh along with force of Hura PS held raid in the Gita Line Hotel at Lodhurka beside NH60A (Purulia -Bankura pitch Road) under PS Hura against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling Country Spirit bottles (DIL KHUSH), which were kept his Hotel at Lodhurka under Hura PS Dist Purulia. I asked him to produce any valid documents/ Licence in respect of selling and stocking Country Spirit bottles but he failed to produce the same. So he committed offence U/S 46A(C) B.E. Act. Accordingly I arrested him after preparing proper Arrest Memo, maintained all formalities regarding arrest, informed ground of arrest and supplied one copy of Memo of Arrest to him and also informed his family members over phone regarding arrest. Then, I seized all the sealed Country Spirit bottles (details are in attached seizure list) after preparing proper seizure list duly signed by the witnesses and accused. I also labeled sample one bottle each. This is to note here that on seeing police personnel all public/customers leave the place. Total 39 (Thirty Nine) bottles DIL KHUSH, ( Plastic bottles 20 and Glass bottles 19) measuring 600 ML each bottle and value Rs. 30 each. Total value of seized liquors are Rs 1170/- (one thousand one hundred and seventy only).

Under the above fact and circumstances, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused Barani Mahato (30 yrs) s/o late Raban ch. Mahato of Village Bahandih PS Hura Dist. Purulia and arrange for its investigation.


